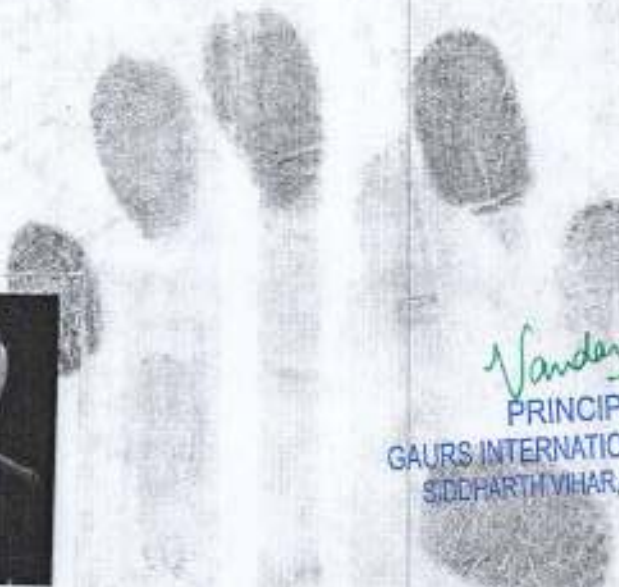

- 7.2 To accept donations, contributions, grants, subscription in cash or in kind from any person, company, firm, association, organizations, government, non government or semi government agencies, national or foreign funding agencies, family Trust, or corporate bodies for furtherance and achievement of the objectives of the Trust.
- 7.3 To review the affairs of the Trust as and when necessary.
- 7.4 To appoint and remove officers and members of staff for the Trust and to prescribe their condition of service.
- 7.5 To open and to provide for operating banking accounts.
- 7.6 To raise loans with or without security or to invite donation and financial help.
- 7.7 To receive the honorarium against his/her services or involvement in any of the project run by the Trust, which must be decided by the Board of Trustees and approved by the Chairman / Chairperson.

- 7.16 To mortgage and give guarantee of the assets and property of the Trust, including the bank guarantee on behalf of the Trust to corporate bodies, persons, firms, institutions, as Trustees may decide from time to time. The Trustees shall not be personally liable for such guarantees or the securities.
- 7.17 To appoint lawyer, pleaders, advocates to file and defend suit or suits filed for and against the Trust and or in the name of the Trust and also file suits for financial and other disputes or dues with different parties and signed executed such application, petition documents for such proceedings and delegate powers to the officers(s), employee(s), staff(s) and Trustee(s) for such proceedings(s) as required from time to time.
- 7.18 To appoint new member or members of Board of Trustees by a resolution and to discharge any of the Trustee, who become bankrupt or acts in any manner prejudicial to the interest or objects of the Trust or is convicted of an offence involving moral turpitude or becomes of unsound mind or is otherwise unfit to continue as Trustee, by resolution passed by simple majority of members present and voting in the meeting of Board of Trustees.
- 7.19 After defraying all necessary expenses incurred in the collection or realization of the income from the Trust ten percent (10%) of the balance of the income shall be kept in a reserve fund to be utilized when, in the opinion of the Board of Trustees, there is any emergency and the remaining income may be utilized for the purpose of the Trust.
- 7.20 The Trustees shall invest the Trust fund in government securities, saving certificates, fixed deposits or in any other form of investment authorized under provisions of INDIAN TRUST ACT and INDIAN INCOME TAX ACT, 1961, as they shall deem expedient.
- 7.21 It has further been decided that as and when the Trust is enclosed or dissolved all the funds of the Trust shall be transferred to the other recognized Public Charitable Trust having similar objectives.

- 8.5. To provide medical, Para-Medical, nursing and dental education.
- 8.6. To provide Management, Law and hotel management education.
- 8.7. To provide technical, non-technical, E-Commerce, computer and other upcoming in the field of education.
- 8.8. To do all other act and deeds as may be necessary or conducive to attain the above objectives.

9. Trust may add any public charitable objectives

The Trustees shall have full power and absolute authority to add to and introduce other specific public charitable objects not inconsistent with objects and purpose of these presents and according to the advancing times and circumstances which may exist from time to time and deem desirable. In that case each newly added objects so decided upon by the trustees shall be deemed to have been incorporated in the objects of these presents.

If any of the above objects is found to be inconsistent with the objects of a public charitable institution under section 11 or any other section of the Income Tax Act, 1961 or any other direct tax law or any law applicable to such trusts as now enacted or as may be enacted or amended at a future date, the object stated above will be treated as so modified to accord with such law or amended law so that any concessions, privileges, conditions or regulations available to and applicable to such public charitable institutions will be available or applicable to this Trust as well so that this Trust will continue to retain its character as a public charitable institution without profit motive with public character within the meaning of all such laws. All the objects of the trust and its activities will be confined to India and will be carried on without profit motive and without any distinction on account of caste, creed, color or religion.

10. Constitution of Board of Trustees:

The constitution of Board of Trustees will be as follows:-

- 10.1 The Board of Trustees shall have as its members all Trustees as given in clause-3 of the deed.
- 10.2 The Board of Trustees will appoint Chairman in every meeting who will preside over the meeting and conduct the proceedings.

11. Operation of Bank Account

The operation of Bank account will be done by minimum two trustees duly authorized by board of trustees.

12. Power to Borrow & Guarantee

12.1 The Board of Trustees shall have overall power of superintendence over the affairs of the Trust. The board will be authorized to borrow monies to carry out the objectives of the trust.

12.2 To give guarantee of the assets and property of the Trust, including the bank guarantee on behalf of the Trust to corporate bodies, persons, firms, institutions, as Trustees may decide from time to time. The Trustees shall not be personally liable for such guarantees or the securities.

13. Proper accounts for the trust shall be kept at the office of the trust. Accounts will be closed on every 31st March or as may be decided by Board of Trustees. Such accounts shall be audited by qualified Chartered Accountant within six months from the end of accounting year.
14. The Trust fund may be augmented by the income from the initial fund and also by donations and other contribution received from time to time. Further, trust fund will also be augmented from surplus in the books of trust.
15. The funds of trust shall not applied for any purpose other then the objects of the trust.
16. Rules may be framed for the proper administrations of the trust, but such rules shall not be against the objects of the trust as stated in clauses 8 above
17. No Benefit to Settler, Trustees and others:
Trustee will not be entitled to any remuneration save right to reimbursement of expenses incurred in discharge of their duties. Neither the settler, trustees nor their families, nor any member of their families nor any of their relatives or concerns in which any of these persons are interested will be entitled to any benefit prohibited by Section 13 or otherwise directly or indirectly from the Trust.
18. The Board of Trustees shall meet as after as may be necessary or convenient to transact business. The board of Trustees might transact business and take decisions also by circulation of paper.
19. All decisions of the Board of Trustees shall be taken either unanimously or by majority and if the Board is equally divided, the Chairman will have the casting vote.
20. Without prejudice the powers of the Board of Trustees, the Managing Committee shall Manage and administer the affairs of the trust and shall also exercise such powers and functions as may be delegated to the Managing Committee by the Board of Trustees.

22. 24. All actions and proceedings of the trust shall be taken and conducted in the name of the trust.

25. Removal of Board of Trustees

Any trustee can be removed from Trusteeship for insolvency or misconduct after a resolution by consensus of all other trustees after opportunity to him in writing.

26. Meeting of the Trust

- 26.1 Meeting of the Board of trustees will be held once in a quarter.
- 26.2 Meeting of the Managing Committee will be held once in a month.
- 26.3 Emergency meeting can be called of Board of Trustees after receiving notice by 3 members.

Decision in meeting will be done by majority.

27. Dissolution

- 27.1 In case it becomes necessary to wind up or otherwise determine this Trust for whatsoever reason, neither the settler nor his heirs nor the Trustees for the time being nor any other person shall have in any manner right over the such funds of the Trust or any other property.
