Sl. No.	The school is directed to ensure that :
1	The total number of sections of Bal Vatika shall be restricted to 03 (one sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to XII shall be restricted to 18 of which not more than 1/3rd sections may be used for senior secondary classes. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension.
2	The school has submitted a few documents through email dated 15-05-2024 i.e. lease document, permanent recognition certificate, letter addressed to issuing authority of building safety certificate for "Error in the school safety certificate, as per school it does not have basement. Thus, the school is required to submit the said certificates / documents along with revised building safety certificate within 03 months in the compliance.
3	The school is required to construct the partition in boy's urinals within 03 months and submit the compliance.
4	The school has constructed the CwSN toilets, out of which some toilets are very narrow and do not have sufficient space for easy movement of wheelchair. Thus, the school is required to ensure that it should have toilets for CwSN separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as

well as handrail on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and board's guidelines and submit the video link covering all the CwSN toilets within 03 months in the compliance

5 The biology lab and composite science lab are partially shown in the inspection videography and workstation/ demonstration of the labs have not been covered. Thus, the school is directed to set-up / maintain both the labs in light of Board's SoP and submit complete internal view of both of the labs with signage within 03 months in the compliance.

6 The school shall conduct training of its teachers with CoE Noida within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.



Sl. No.	The school is directed to ensure that :
1	The total number of sections of Bal Vatika shall be restricted to 3 (for Bal Vatika I, II & III).The total number of sections from classes I to XII shall be restricted to 13. Any further increase shall require prior permission of the Board and shall be subject to compliance with the affiliation Bye laws and availability of rooms of >500 sq ft dimensions.
2	The school has not referred to RPwD Act or Board's guidelines on CWSN toilets.It has converted regular cubicles into CWSN toilets, which are very narrow and there is no room for a wheelchair/walker to navigate. The grab bars are inappropriately placed. In the first washroom seen in the video, a cubicle has been indicated as CWSN toilet without any infrastructural support inside.All signages are temporary, pasted for the purpose of inspection.This is not acceptable.Thus, the school is required to construct the CWSN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and board's guidelines within 03 months and submit the compliance.

3	Safety features like exhaust fan, fire extinguisher are also not available in Composite lab. Hence the school is directed to upgrade the labs as per SoP issued by the Board and submit the compliance within 3 months.
4	Library is understocked and reading area for students and staff are inadequate. The seating in the library should be comfortable. there are wooden benches in place of chairs. Hence the school is directed to upgrade the library as per SoP issued by the Board and submit the compliance within 3 months.
5	The ramp at the entrance of the building does not have hand railings for support. The school shall affix hand railings along both sides of the ramp within 3 months and submit compliance on SARAS.
6	The school has made a child sit on a wheelchair to demonstrate its CWSN infrastructure which is reprehensible. the board does not approve of such practices and the school is warned not to resort to this practice in the future.
7	The school shall conduct training of its teachers with CoE Noida within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-
